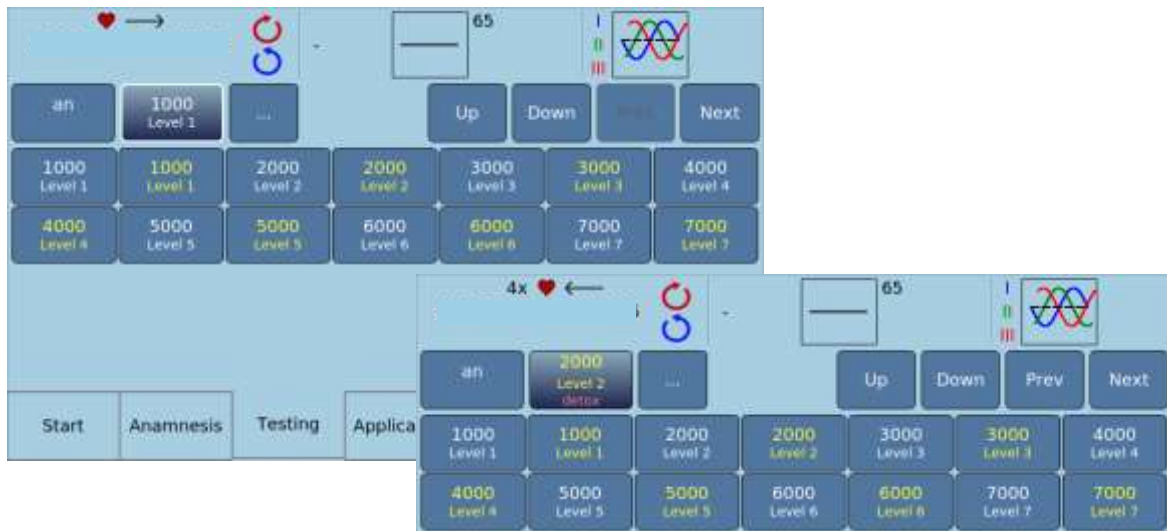
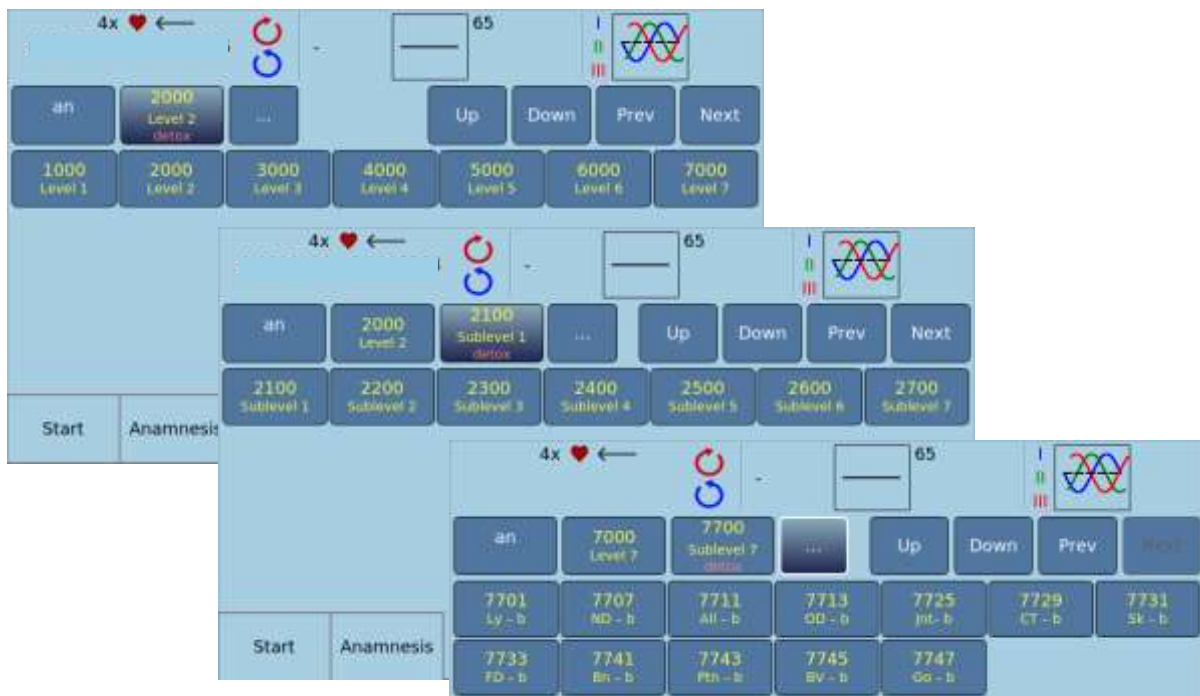


Changes due to upgrade to version 6.3.0#4

With this upgrade, new program buttons are added on the first two hierarchy levels (levels and sublevels).



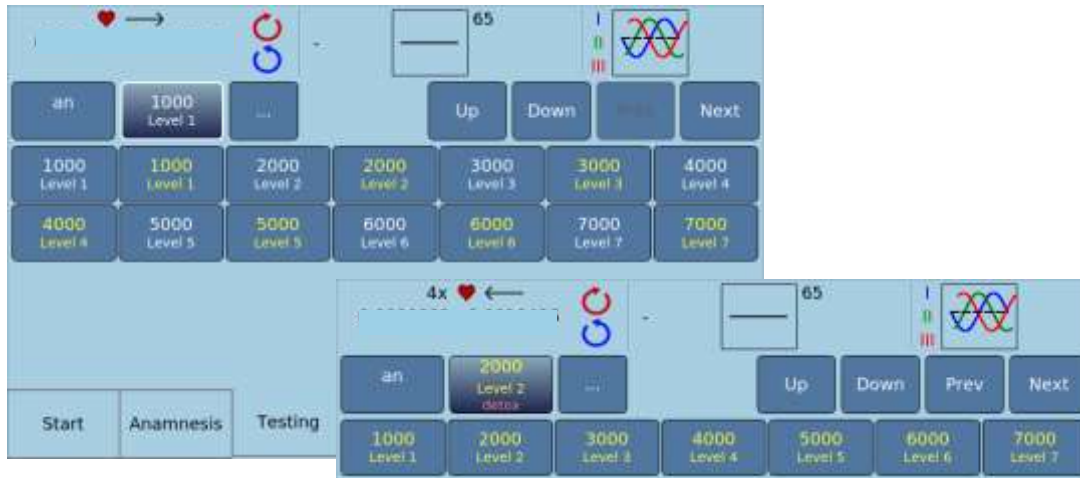
These are assigned to the wobbled frequency programs in descending order (Wob.dir ←). They can be recognized by the yellow font color on all levels (including the programs of the "TCM" library).



By means of the function key "Cascade" you can switch as usual between the views

- "only ascending wobbled programs" (default, white font, Wob.dir →),
- "all programs" or
- "only programs wobbled in descending order" (yellow font, Wob.dir ←)

This is now also possible on the first two hierarchy levels "level" and "sublevel".

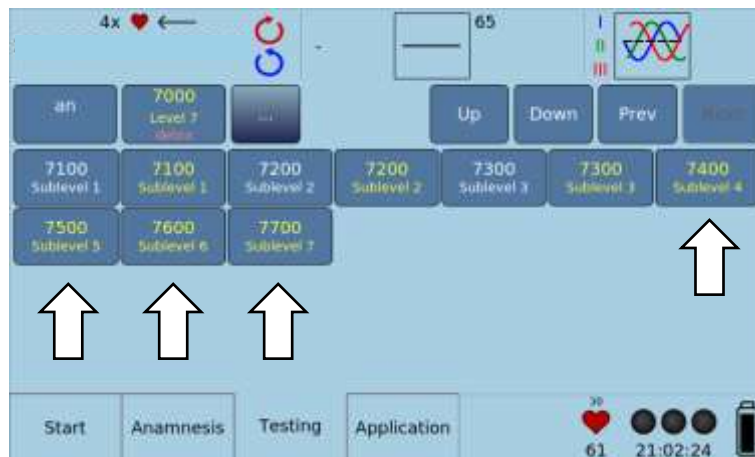


If a frequency program is called up, the "Cascade" key switches back and forth between the ascending and descending wobbled program.

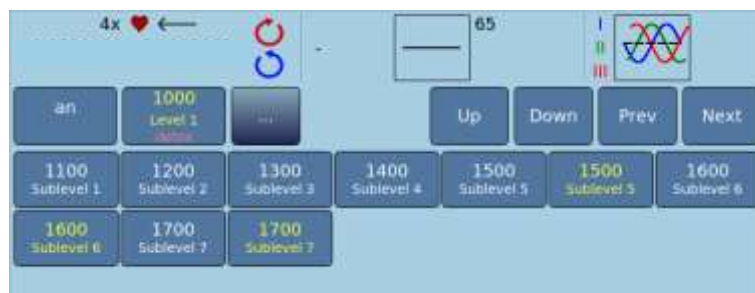


Attention: The assignment of the frequency ranges to the descending wobbled program numbers has been shifted by 4 sublevel numbers. The frequencies of the descending programs are lowered by a factor of 16 (4 octaves) compared to the ascending ones.

For this purpose, the programs 7400 to 7700 were added on level 7. These sublevels contain only descending wobbled programs.



In contrast, the "yellow" program numbers on level 1 do not start until 1500. On sublevels 1100 to 1400, there are only programs wobbled in ascending order.



➤ **Please note this change in program numbers with your previous documentation.**

The change of program numbers was also performed for the chord function and the "Intelligent Anamnesis Analysis" license.

Comparison of the program numbers old and new

Attention - this change applies **only to the frequency programs wobbled in descending order (Wob.dir ←)** with yellow lettering! The ascending wobbled programs (Wob.dir →) with white font are unchanged.
